- File your application through an immigration attorney with all supporting documentation
- Obtain interview with US Consulate
- Get awarded E-2 Visa
- Enter the United States

E-2 INVESTOR VISA DETAILS

An E-2 Investor Visa allows an individual who is a national of a country with which the United States maintains a treaty of commerce and navigation to enter and work within the United States.

We will assist applicants of popular EB-5 filing countries such as China, India, Vietnam, Russia, Brazil, and South Africa, which are not E-2 treaty countries, to obtain citizenship from a qualifying E-2 treaty country, such as Grenada or Turkey, before applying for their U.S. E-2 Visa.

A foreign investor may qualify for a E-2 Visa only by making a substantial investment in a US based-business. Furthermore, this business must demonstrate financial success, producing enough income to cover the well-being of the investor and his or her family. The investor is required to "develop and direct" the business, but not manage daily activity.

The business will be evaluated every 5 years for renewal dependent upon the continued success and growth of the business.
